

- Interested Persons/Parties must forward their proposal in the sealed envelope mentioning "Proposal for Purchasing Vehicle No....." on the top of the envelope based on following terms and conditions. The tender must enclose KYC documents (Aadhar Card, PAN Card, Driving License, Passport etc.) Proposals should reach our Head Office on or before 15.11.2021 upto 04.00 P.M. Please mark your Contact No. on the envelope of the tender.
- Unsealed Tenders, if any, will be summarily rejected.
- The tender received without EMD (Bank draft) and after the stipulated date and time will not be accepted.
- Separate Demand Draft of EMD for Rs.5000/- must accompany with the proposals for each vehicle and DD should be in favour of 'PUNJAB GRAMIN BANK'.
- The tender will be opened on 17.11.2021 at 11.00 AM. In Conference Hall of Punjab Gramin Bank, Head Office, Jalandhar Road, Opp. Petrol Pump, Kapurthala, Punjab - 144601 in the presence of the tenderers who wish to be present.
- Vehicle may be inspected on 08.11.2021 between 11.00 A.M. to 05.00 P.M.

7. Successful tenderer will have to deposit entire amount within 7 days from the date of intimation by the Bank in this regard. In case successful tenderer fails to deposit money, the EMD will be forfeited.
8. Further physical possession of vehicle & refund of Earnest Money deposit will be refunded only after furnishing proof of RC duly transferred in favour of the successful bidder within a period of 1 month.
9. In case successful tenderers desired to re-register the vehicle outside Punjab, where the vehicle needs to be produced physically, an extra amount of Rs. 25,000.00 has to be deposited other than EMD which will be refundable only after furnishing proof of RC duly transferred in favour of the successful bidder within a period of 1 month. Once the release order issued, this office will not be responsible either for safe custody or for any loss or damage to the subject vehicle.
10. The highest bid once accepted is not transferable to anyone. In case the bidder is a company, the name of company should be indicated as the bidder. In such cases the person appearing for the company should have the authorization letter in a proper format issued from a competent authority of the company. Request to change the name of the bidder in the tender after submission of the tender will not be entertained.
11. Only the highest bid amount over and above the minimum reserve price will be accepted. If the highest bidder (H-1) refuses to purchase the vehicle, the same may be sold to H-2 on the rate quoted by H-1
12. Tendering Firm/Individual will alone be responsible for furnishing any false or wrong information and the consequences or loss thereof.
13. EMD of unsuccessful tenderers will be refunded without any interest within Reasonable time.
14. Vehicle is to be disposed off on "AS IS WHERE IS" basis.
15. Bank will not be liable to accept the highest bidder & reserves the rights to reject any or all of the tenders without assigning any reason thereof. The decision of the Bank in this regard in this shall be final & binding.
